Management's Discussion and Analysis of Financial Condition and Results of Operations

The following Management's Discussion and Analysis ("MD&A") of Premier Gold Mines Limited (the "Corporation" or "Premier") should be read in conjunction with the unaudited condensed consolidated interim financial statements for the three and nine months ended September 30, 2017 and the notes thereto. The Corporation's unaudited condensed consolidated interim financial statements have been prepared in accordance with International Financial Reporting Standards ("IFRS") as issued by the International Accounting Standards Board ("IASB"). Unless otherwise stated, all amounts discussed herein are denominated in Canadian dollars. This MD&A was prepared as of November 7, 2017 and all information is current as of such date. Readers are encouraged to read the Corporation's public information filings on SEDAR at www.sedar.com.

This discussion provides management's analysis of Premier's historical financial and operating results and provides estimates of Premier's future financial and operating performance based on information currently available. Actual results will vary from estimates and the variances may be significant. Readers should be aware that historical results are not necessarily indicative of future performance.

OVERVIEW

Company Overview

Premier is a growth oriented, Canadian based, mining company involved in the exploration, development and production of gold and silver deposits in Canada, United States and Mexico. The Corporation's common shares are listed on the Toronto Stock Exchange ("TSX") under the symbol PG and its head office is located at Suite 200, 1100 Russell Street, Thunder Bay, Ontario, P7B 5N2.

The Corporation's principal mining assets include:

- Wholly owned Mercedes Mine in Sonora, Mexico,
- A 40% interest in the South Arturo Mine in Nevada, USA, and
- A 50% interest in the Hardrock Gold Project through a partnership with Greenstone Gold Mines located along the Trans-Canada highway in Ontario, Canada.

Other key exploration properties include:

- A 100% interest in the McCoy-Cove gold property located in Nevada, USA,
- A 100% interest in the Hasaga Gold Project in Red Lake, Ontario, Canada, and,
- A 44% joint venture interest with Goldcorp in the Rahill Bonanza projects, also of Red Lake Ontario, Canada.

2017 Third Quarter Highlights

The Company's formal reporting currency is in Canadian dollars however for convenience to the reader, conversions to United States currency (US\$) is also provided for several of the following key highlights.⁽ⁱⁱ⁾

- Production of 26,677 ounces of gold and 82,856 ounces of silver
- Gold sales of 37,920 ounces at an average realized price⁽ⁱ⁾ of \$1,604 (US\$1,282) per ounce
- Co-product cash costs⁽ⁱ⁾ of US\$646 per ounce of gold⁽ⁱⁱ⁾
- Co-product all in sustaining costs ("AISC")⁽ⁱ⁾ of US\$782 per ounce of gold
- Net revenue of \$62.3 million (US\$47.7 million)
- Operating income of \$17.0 million (US\$13.0 million)
- Net income of \$3.9 million (US\$3.0 million)
- Quarter end cash balance of \$171.8 million (US\$137.6 million)
- Cash flow from operating activities of \$25.6 million (US\$19.6 million) or \$0.12/share (US\$.09/share)
- Free cash flow⁽ⁱ⁾ of \$17.1 million (US\$13.1 million) or \$0.08/share (US\$0.06/share) after an investment of \$6.9 million (US\$5.3 million) in exploration and pre-development programs and \$8.4 million (US\$6.4 million) in capital expenditures.

2017 Guidance

On July 18th, 2017 the Corporation announced an increase in full-year production guidance to 130,000 to 140,000 ounces of gold production from its operations at South Arturo and Mercedes as well as 340,000 to 365,000 ounces of silver from Mercedes only.

Production estimates for 2017 are derived from life of mine operating plans prepared on the basis of mineral reserves associated with each property. The underlying assumptions for the estimates are presented in the table below.

Net income / (loss) generally reflects the level of exploration, evaluation and pre-development activity and general and administration costs up until gold production began at the South Arturo project in the second quarter of 2016 and the purchase of Mercedes mine at the end of the third quarter of 2016.

Gold sales for the third quarter of 2017 amounted to 37,920 ounces, of which 24,894 ounces were from Mercedes and 13,026 ounces from South Arturo. The downward trend in sales ounces is a product of the decreasing production attributable to Premier from South Arturo and a slight decrease in Mercedes production as discussed in the mining operations section. Mercedes sales have remained relatively constant due to the timing of sales from inventory. The declining production for South Arturo in 2017 is the result of the planned completion of Phase 2 mining combined with the sequencing of higher grade ores in 2016. Overall mine operating revenue is consistent with slightly lower sales ounces and a decrease in the average gold price on sales from the first two quarters of 2017.

Third Quarter Results

Three and nine months ended September 30, 2017 and 2016

Certain items within the statements of income / (loss) and comprehensive income / (loss) have been reclassified in the current period. The prior periods have been restated to reflect the change in presentation.

Operating income for the three and nine months ended September 30, 2017 was \$7,152,324 and \$36,473,522 respectively compared to a loss of \$7,315,331 and \$31,463,723 for the same periods of 2016 for a positive variance of \$14,467,655 and \$67,937,245. Of this variance, \$13,556,027 and \$70,714,757 are from mine operating income from gold production at the South Arturo project as well as gold and silver production from the Mercedes Mine acquired on September 30, 2016. See mining operations discussion below.

- Decrease of \$1,882,923 and increase of \$3,247,822 for the three and nine months ended September 30 from 2016 to 2017 in exploration, evaluation and pre-development mainly due to:
 - Hasaga exploration program and Greenstone Gold pre-development work down from this period last year;
 - year to date there has been additional pre-development work at the McCoy-Cove project in Nevada despite a decrease in this quarter due to timing of the pre-development work;
 - decreased expenditures on existing projects offset by expenses on other projects added in the last half of 2016 including Goldbanks in Nevada and Cristina in Mexico;
 - see exploration, evaluation and pre-development discussion in section below.
- Decrease in property maintenance of \$21,548 and \$347,480 for the three and nine months ended September 30 from 2016 to 2017 due to costs incurred in 2016 for environmental reviews of non-core properties not required in 2017
- Increase in general and administration of \$305,747 in the three months ended September 30, with a year to date positive variance compared to 2016 of \$220,159 including:
 - increase in corporate administration costs of \$23,599 and \$430,478 and salaries and benefits of \$421,678 and \$1,258,434 respectively, mainly due to the addition of a USA based office and staff;
 - decrease of \$148,514 and \$2,057,823 respectively in general and administrative costs related to the reduction in project management fees once the South Arturo project reached production.
- Increase of \$14,958 and decrease of \$429,111 in share based payments for the three and nine months ended September 30, 2017 compared to 2016 respectively due to:
 - no stock options granted in the three months ended September 30, 2017, vesting of \$69,373 on existing options;
 - payment of \$304,086 vested RSUs less fair value adjustment to vesting of \$67,712.
- Decrease of \$672,138 and \$526,440 in remeasurement of environmental rehabilitation provision compared to 2016 as no significant changes in estimate to non-core properties which are expensed on reassessment of the liability.

The variance for other income / (expense) for the three and nine months ended September 30, 2017 and 2016 was \$540,717 and (\$3,600,422) respectively. The components of other income and expense are listed in the table with comments below:

Significant variances for the three and nine months ended September 30, 2016 and 2017 are due to:

- Increase in other income for interest earned on higher cash balances.
- Smaller mark to market losses on investments for the three and nine months ended September 30, 2017 versus gains experienced in 2016 on the disposal of Canadian equities.
- A decrease in loss on derivatives of \$424,955 and \$3,547,516 that includes:
 - a loss of \$77,147 and \$414,790 and a gain of \$54,073 and \$214,385 for the three and nine months ended September 30, 2017 and 2016 respectively for the fair value adjustment on the offtake obligation under the Orion financing agreement;
 - the mark to market and settled loss on put options was \$347,800 and \$4,624,202 for the three and nine months ended September 30, 2016 (nil for 2017);
 - a loss of \$529,000 on the valuation of a forward contract for the three and nine months ended September 30, 2016 (nil for 2017).
- An increase in the net foreign exchange gain of \$1,787,237 and \$483,962 for the three and nine months ended September 30, 2017 and 2016 due to the strengthening of the Canadian dollar to the US dollar including:
 - a five basis point for the three months ended September 30, 2017 versus a two basis point swing in 2016;
 - a ten basis point swing for the nine months ended September 30, 2017 versus a seven basis point swing in 2016;
 - in addition, the Corporation entered into US\$ denominated debt and deferred revenue arrangements in late June, 2016.
- A decrease in the gain attributable to the Greenstone Gold development commitment of \$2,126,317 and \$5,959,388 for the three and nine months ended September 30, 2017 and 2016 mainly due to the completion of the feasibility study in 2016 and a decrease in activity for 2017 pending completion of the environmental assessment process.

Finance costs for the three months ended September 30, 2017 were \$2,768,092 compared to \$326,601 in 2016 and \$7,938,279 for the nine months ended September 30, 2017 compared to \$607,649 in 2016 due to the financing that was entered into late second and third quarter of 2016. Cash interest costs were \$1,602,560 and \$5,036,749 for the quarter and year to date in 2017 respectively. Finance cost also includes the amortization of costs incurred in the financing entered into in 2016 and as fully described in the December 31, 2016 audited consolidated financial statements.



Current and deferred income tax

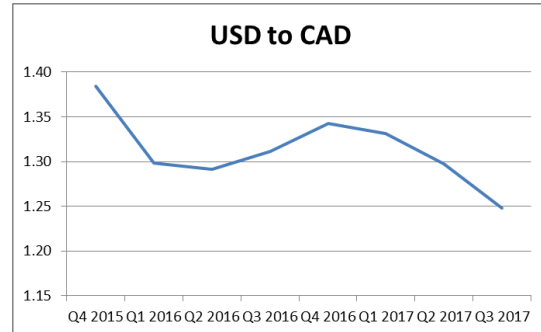
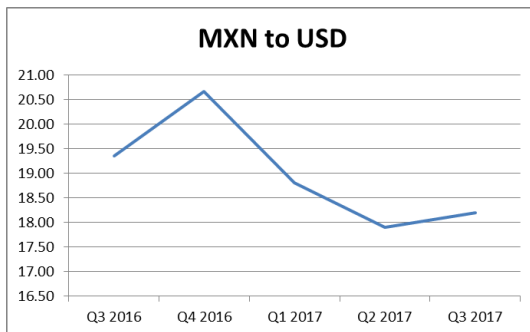
Current income taxes are comprised of net proceeds tax in Nevada on the South Arturo mine operations, alternative minimum tax on the US operations and royalty and income tax expense on the Mercedes mine in Mexico. Deferred tax recoveries are related to the Mercedes mine operations for previously unrecorded deferred tax assets, deferred royalty taxes related to non-monetary exchange gains / losses included in the timing differences and a deferred tax recovery for the alternative minimum tax paid that can be applied to regular income tax in the US.

Other comprehensive income / (loss)

Total comprehensive income / (loss) was a loss of \$4,372,373 and income of \$10,278,586 for the three and nine months ended September 30, 2017 compared to a comprehensive loss of \$1,807,923 and \$34,075,769 for the three and nine months ended September 30, 2016.

Other comprehensive income / (loss) is comprised of exchange differences on the translation of foreign operations and related deferred income taxes that resulted in a net loss of \$8,238,568 and \$14,889,212 for the three and nine months ended September 30, 2017 based on a stronger Canadian dollar (ten basis points compared to the US dollar). A gain of \$3,249,602 and a loss of \$6,329,724 was recorded for three and nine months ended September 30, 2016 due to a less significant improvement in the Canadian dollar during this period (five basis points for the quarter, seven basis points year to date) and less foreign activity. Mining operations that commenced in the last half of 2016, operate with a functional currency of USD and contribute to the larger cumulative translation adjustment on the net assets in 2017.

The Corporation produced 26,677 ounces of gold during the quarter for a total of 115,273 ounces of gold year to date. During the quarter, 82,856 ounces of silver were produced, for a total of 260,902 ounces produced year to date. Gold ounces sold in the quarter were 37,920 while silver ounces sold were 90,545. At quarter end, the Corporation held in inventory 5,933 ounces of gold and 39,659 ounces of silver, for a value of \$6,847,399 and \$641,222 respectively.

Net gold revenue during the quarter was \$60.4 million and net silver revenue was \$1.9 million. Year to date, net gold revenue was \$216.5 million and net silver revenue was \$5.8 million. The quarterly average realized gold price was \$1,604 per ounce and the realized silver price was \$21 per ounce.

Third quarter gold production reflects the planned reduction as the South Arturo Phase 2 open pit mining nears completion. Production from the Mercedes Mine in the third quarter was less than the prior quarter due to two weeks of reduced output resulting from significant range fires near the mine site as well as lower tonnes and grades mined. Metal sales of 37,920 in the third quarter are the result of additional ounces sold from inventories.

Rahill-Bonanza

There was no drilling completed at Rahill-Bonanza during the quarter, the recovery includes:

- \$11,128 in contractor fees offset by a rebate in the amount of \$19,086
- \$7,178 in operations support and property work including wages and benefits

Hasaga

A total of 5,482 metres of drilling was completed at Hasaga during the third quarter. Drilling focused on completion of the framing of Hasaga Deep Horizon, continuing with one drill targeting Hasaga deep C zone infill and some testing to the west towards the Buffalo zones which now appear to be directly related.

Hasaga exploration expenditures for the quarter have been supported by 2016 flow through share financing and are as follows:

- \$611,047 for 5,482 meters of drilling and related costs
- \$89,225 in geological costs including salaries and benefits
- \$42,852 in analytical and sampling costs
- \$151,162 in operations support and property work including wages and benefits

Greenstone

Approximately \$1.9 million was spent by Greenstone Gold in the third quarter (at 100% basis) mainly related to ongoing environmental assessment project activities.

Expenditures at Premier's 50% share during the period include:

- \$10,123 in analytical and sampling costs
- \$112,553 in environmental permitting
- \$2,224 in geology, mine development and metallurgy
- \$379,117 in pre-development infrastructure
- \$135,068 in administrative and other related costs
- \$326,239 in community relations

McCoy-Cove

There was no drilling during the third quarter as the main focus was on the development efforts. Permitting activities related to development ongoing according to plan.

Expenditures during the period include:

- \$-78,629 for drilling related to rebates from the contractor
- \$11,370 in analytical and sampling costs
- \$93,797 in geological and assay costs including salaries and benefits
- \$1,535,329 in mine development, metallurgy and permitting pre- development costs



- \$483,550 in environmental costs
- \$258,485 in operations support and property work including wages and benefits

South Arturo

The South Arturo property exploration activity for the third quarter includes:

- \$143,886 for drilling related cost
- \$203,176 in analytical and sampling costs
- \$226,340 in operations support included allocated site overhead

Goldbanks

A total of 3,245 metres were drilled in five holes during the quarter. Drilling was done to expand the Golden Devil target area as well as drill test projection of main zone to south of Golden Devil. No significant high grade assays were received for the quarter.

Expenditures during the period include:

- \$1,065,022 for drilling related costs
- \$136,444 in analytical and sampling costs
- \$170,995 in geological costs including salaries and benefits
- \$-25,600 in environmental costs
- \$85,904 in operations support and property work including wages and benefits

Mercedes

Exploration drilling continued at an accelerated pace in the third quarter with 19,572 meters for a year to date total of 32,230 metres. This drilling continued to target the Diluvio, Lupita, Casa Blanca, Lagunas and Rey de Oro areas.

Expensed exploration is related to the concession fees of \$359,753 for the 46 lots covering the 70,865 hectares.

Capital exploration expenditures of \$2.5 million during the period include:

- \$1,470,541 for 19,572 meters of drilling related costs
- \$248,936 in analytical and sampling costs
- \$204,335 in geological costs including salaries and benefits
- \$361,608 in supplies and maintenance of own equipment
- \$255,736 in consulting and other expenditures

Cristina

The Corporation will not to continue with the exploration option on the Cristina property recording a loss on the write off of the mineral interest option payment in the amount of \$1,868,773. Expenditures during the period include:

- \$8,170 for drilling and related costs
- \$32,181 in analytical and sampling costs
- \$19,194 in geological and assay costs including salaries and benefits
- \$183,040 in operations support and property work including wages and benefits

Cumulative exploration and pre-development expenses to date by project

The Corporation prepares its consolidated annual financial statements in accordance with International Financial Reporting Standards ("IFRS") as issued by the International Accounting Standards Board ("IASB").

The variance in net income / (loss) from 2014 to 2015 is largely related to the consolidation and divestment of mineral property interests which notably includes the gain on Premier's divestment of a 50% interest in the Hardrock and Brookbank properties to the Greenstone Gold Mines partnership. The onset of production from South Arturo and Mercedes in 2016 had a significant impact on operations and the Corporation's 2016 cash position.

FINANCIAL POSITION

Balance Sheet Review

As at September 30, 2017, total assets were \$579,353,988, down \$2,025,512 from \$583,601,586 at December 31, 2016.

Current assets decreased by \$4,614,442 including:

- \$52,081,586 increase in cash balances generated mainly from operating activities, see *Liquidity and Capital Resources*.
- \$56,115,535 decrease in inventory at Mercedes and South Arturo.
 - \$7,351,015 decrease in Mercedes inventory, \$5,801,265 of the decrease in finished goods inventory (4,226 gold ounces at September 30, 2017 versus 9,772 at December 31, 2106).
 - \$48,764,520 decrease in South Arturo inventory, \$36,756,079 decrease in stockpile inventory and \$12,008,441 in finished goods inventory (1,707 gold ounces at September 30, 2017 versus 13,614 at December 31, 2106).
- \$2,861,274 increase in receivables includes recoverable income and other taxes for Mercedes of \$1,782,223.
- \$4,182,300 decrease in other assets due to the reduction in Canadian equities held of \$1,886,790, elimination of derivative investments on the expiry of puts of \$490,012 and the reversal of the forward contract gain of \$1,805,498 on settlement.

Current liabilities increased by \$46,020,502 including:

- \$50,026,573 increase in current portion of long term debt, \$53,605,995 for the reclassification of the Orion debt from long term to current (due June 30, 2018) offset by the repayment of the final instalment of the Newmont note for \$2,685,400.
- \$7,657,497 decrease in current payables resulting from the Mercedes purchase and related increased accruals included in the December 31, 2016 balances.
- \$5,512,605 increase in current taxes payable for net proceeds tax in Nevada, mining royalty tax in Mexico and alternative minimum tax on the US operations.
- \$770,924 increase in current portion of environmental liabilities for expected spending for the balance of 2017 and first half of 2018.

The working capital ratio as at September 30, 2017 is 2.1:1 compared to 3.8:1 at December 31, 2016 due mainly to the increase in the current portion of long term debt.

Non-current assets increased by \$366,844 including:

- \$10,254,433 decrease in property plant and equipment, \$31,498,144 in capital additions (including capitalized environmental rehabilitation) offset by a currency adjustment of \$33,574,366 and a reduction of \$1,850,447 for an option payment write off on the Cristina mineral interest in Mexico that was dropped during the period.
- \$24,823,315 in depletion, depreciation and amortization offset by a currency adjustment of \$18,495,551.

Non-current liabilities decreased by \$65,100,974 including:

- \$3,400,311 decrease in deferred regular and royalty taxes at Mercedes.
- \$15,936,915 decrease for the long term portion of the deferred revenue due to the quarterly settlement of the gold prepay and silver stream arrangements discussed in Note 10 of the September 30, 2107 unaudited condensed consolidated interim financial statements.
- \$53,065,312 decrease in long term debt mainly due to the reclassification to current on the Orion debt as discussed above.



Liquidity and Capital Resources

As at September 30, 2017, the Corporation had cash and cash equivalents of \$171,785,972, an increase of \$52,081,586 from \$119,704,386 at December 31, 2016.

\$81,246,571 was generated from operating activities including;

- \$132,706,628 from mining operations after adding back non-cash depletion included in inventory,
- \$26,822,727 spent in exploration and pre-development activities (offset by the Greenstone Gold development commitment gain of \$4,836,543),
- \$13,348,109 deducted for deferred revenue on metal agreements included in operating revenue,
- \$7,319,783 spent in general and project administration expenditures,
- \$4,432,630 in working capital decreases due to the reduction in the cash cost in inventory offset by the reduction in accounts payable and accrued liabilities.

\$20,511,136 was spent in investment activities including \$21,567,084 for capital spending for mining operations.

\$5,999,239 cash was used in financing activities with \$5,036,749 in interest charges paid and \$2,668,660 for the Newmont debt repayment.

For the three months ended September 30, 2017, the Corporation generated \$25,552,978 in cash from operating activities compared to use of cash of \$24,288,704 for the same period of 2016. The cash generated in 2017 is directly related to onset of production from South Arturo and Mercedes in the last half of 2016. Cash used in 2016 was for exploration, evaluation and pre-development activities including capitalized development at South Arturo.

Premier funds current exploration, evaluation, pre-development and development expenditures through existing cash and financings. The Corporation anticipates that it will have sufficient funds to manage current projects through 2018 and is actively managing the ongoing pre-development activities at the Greenstone Gold property through its partnership agreement with Centerra (who continues to sole-fund the project). The South Arturo and Mercedes properties continue to generate income and positive cash flow from operations.

Premier typically funds a portion of its Canadian exploration activities via flow-through share financings. Resource expenditure deductions for income tax purposes related to exploration and development activities funded by flow-through shares are renounced to investors in accordance with income tax legislation. All of the flow-through financing completed on October 14, 2016 has been spent prior to the December 31, 2017 deadline.

Equity

The Corporation is authorized to issue an unlimited number of common shares of which 202,159,187 were outstanding at September 30, 2017 and at the date of this report, November 7, 2017. At September 30, 2017 the Corporation had outstanding options to purchase an aggregate of 9,020,900 common shares under its share incentive plan with exercise prices ranging from \$1.40 to \$5.40 per share and expiry dates ranging from October 24, 2017 to March 29, 2022. At November 7, 2017 the Corporation had 8,960,900 options outstanding after the expiry of 60,000 options on October 24, 2017. At September 30, 2017 there were 265,000 unvested stock options.

During the nine months ended September 30, 2017, 302,000 RSU's were issued under the restricted share unit plan of the Corporation. Each RSU has the same value as one Premier Gold Mines Limited common share. The RSUs vest equally over a three year period vesting on August 31 of each year. The RSUs are expected to settle in cash. During the period, 11,000 RSUs were cancelled and on August 31, 2017, the first tranche of vested RSUs were settled in cash in the amount of \$375,390.



Normal course issuer bid

On July 20, 2017 the Corporation announced that approval had been received from the Toronto Stock Exchange for a normal course issuer bid to purchase up to 19,599,646 of its issued and outstanding shares. The purchase of the shares may commence on July 25, 2017 and end on July 24, 2018. No shares have been purchased under the bid to date.

The planned completion of Phase 2 at South Arturo resulted in lower production at 8,113 ounces of gold as compared to the second quarter. Mercedes provided the majority of production for the company with 18,564 ounces of gold in the quarter. Accordingly, total net gold revenue for the quarter includes \$39.7 million from Mercedes and \$20.7 million from South Arturo. Total net silver revenue was \$1.9 million. The average realized gold price (refer to "Non-IFRS Measures") for the quarter was \$1,587 per ounce for South Arturo and \$1,612 per ounce for Mercedes.



In the quarter, South Arturo co-product cash costs (refer to “Non-IFRS Measures”) were US\$363 per ounce of gold sold, while co-product all in sustaining costs (refer to “Non-IFRS Measures”) were US\$371 per ounce of gold sold. Mercedes co-product cash costs were US\$793 per ounce of gold sold, while co-product all in sustaining costs were US\$998 per ounce of gold sold.

The Corporation has also provided by-product information (refer to “Non-IFRS Measures”). Accordingly, Mercedes by-product cash costs in the quarter were US\$772 per ounce of gold sold, while all in sustaining costs were US\$988 per ounce of gold sold.

Net gold revenue at Mercedes year to date was \$110.8 million and net silver revenue was \$5.8 million. South Arturo net gold revenue year to date was \$105.7 million, resulting in total net gold revenue of \$216.5 million year to date. The average realized gold price (refer to “Non-IFRS Measures”) at Mercedes year to date was \$1,631 per ounce while South Arturo averaged \$1,635 per ounce, resulting in a consolidated year to date average of \$1,633 per ounce.

South Arturo co-product cash costs (refer to “Non-IFRS Measures”) year to date were US\$295 per ounce of gold sold, while co-product all in sustaining costs (refer to “Non-IFRS Measures”) year to date were US\$336 per ounce of gold sold. Mercedes co-product cash costs year to date were US\$687 per ounce of gold sold, while co-product all in sustaining costs year to date were US\$839 per ounce of gold sold.

The Corporation has also provided by-product information (refer to “Non-IFRS Measures”). Mercedes by-product cash cost year to date were US\$658 per ounce of gold sold, while by-product all in sustaining costs year to date were US\$818 per ounce of gold sold. South Arturo had no silver related by-product credits.




Mercedes Mine

The Mercedes mine is located 60 kilometres southeast of the town of Magdalena de Kino and 150 kilometres north-northeast of the city of Hermosillo in the state of Sonora, Mexico. Operations are exploiting low sulfidation quartz veins and quartz veinlet stockwork for gold and silver using underground modified overhand cut and fill and longitudinal longhole mining methods at an ore extraction rate of approximately 2,000 tonnes per day. Processing is by wet milling with a Merrill-Crowe recovery system. Proven and probable reserves as of June 30, 2016 totaled 2.9 million tonnes at an average gold grade of 4.32 grams per tonne and silver grade of 35.7 grams per tonne containing 404,000 ounces of gold and 3.34 million ounces of silver.

During the third quarter, the average drill rig count remained at nine and drill meters increased from 9,257 metres in 72 holes in the second quarter to 19,572 meters in 183 holes in the third quarter for a total to date of 32,230 meters drilled in 255 holes. Drilling at Diluvio, Casa Blanca and Barrancas yielded the best results and indicate the potential for additional resources and reserves.

The 2017 exploration program commenced with preliminary testing of several targets. Starting in the second quarter targets were selected for best conversion of ounces to reserves and drilling of these targets is in process and will continue for the remainder of 2017. The focus remains on new mineralization close to existing workings, supporting mine production, extensions to mineralization along strike of the main mine trend and testing new geological targets.

Gold production in the quarter was 15% lower and silver production was 7% lower as compared to the second quarter of 2017. Production was less than the prior period due to lower tonnes and grades mined and processed. Average gold grade processed at 3.88 g/t was 4% less than the second quarter primarily due to mining sequence. Increased delineation drilling is in progress to continue to improve production planning.

Mercedes co-product gold cash costs (refer to "Non-IFRS Measures") for the quarter were US\$793 per ounce of gold sold and year to date were US\$687 per ounce of gold sold, while gold co-product all in sustaining costs (refer to "Non-IFRS Measures") for the quarter were US\$998 per ounce of gold sold and year to date were US\$839 per ounce of gold sold.

Co-product silver cash costs (refer to "Non-IFRS Measures") for the quarter were US\$10 per ounce of silver sold and year to date were US\$9 per ounce of silver sold, while silver co-product all in sustaining costs (refer to "Non-IFRS Measures") for the quarter were US\$13 per ounce of silver sold and year to date were US\$11 per ounce of silver sold.

The average realized gold price (refer to "Non-IFRS Measures") at Mercedes for the quarter was \$1,612 per ounce and \$1,631 per ounce year to date, while the average realized silver price for the quarter was \$21 per ounce, and year to date was \$22 per ounce.

Lower third quarter tonnes processed were primarily due to significant range fires near the mine site, a different mining sequence driven by changes in ground conditions in the Lagunas and Barrancas Zones, and requirements to update the model and the ventilation system for the Diluvio Zone.

The management team continues to assess and execute initiatives to increase mill throughput, reduce dilution and control unit costs. This includes installing a ventilation system for production in Diluvio, continuing to test and improve split blasting designs, and improving ground support designs and systems.



South Arturo Mine

The mine is located 45 kilometres northwest of the town of Carlin, Nevada, USA. Operations are exploiting a Carlin-style disseminated gold deposit by open pit methods. Premier holds a 40% interest in South Arturo with Barrick, who holds the remaining 60% and is the operator of the mine.

A Plan of Operations for the construction of a ramp at El Nino to access high-grade mineralization down dip of the current pit has been submitted for approval with Nevada regulatory authorities. Drilling started in the third quarter and will focus on the further definition of the ore zones from the pit to infill previous surface exploration drilling programs. Drilling also started in the third quarter to test the Ardent target, a geochemical anomaly and possibly a result of leakage along fractures west of the current operations area.

Drilling and a bulk sample program will target the potential for a Dee Pit expansion, and a potential run of mine heap leach operation located to the west of the current Phase 2 pit. Updated metallurgical recoveries and optimized capital and operating assumptions will be used for a revised economic assessment prior to making a construction decision for this potential second open pit operation.

Premier's attributable share of production in the quarter was 8,113 ounces of gold. Third quarter co-product cash costs (refer to "Non-IFRS Measures") were US\$363 per ounce of gold sold while all in sustaining costs were US\$371 per ounce of gold sold. Production and cost performance for the third quarter and year to date has been better than planned due to the positive reconciliation to modeled ore tonnes and grade.

Processing of 79,479 tonnes during the quarter compares to 112,466 tonnes during the second quarter. This reduction is due to the planned completion of Phase 2 mining and the processing of lower grade ore from stockpiles. The planned processing of lower grade ore as compared to the second quarter resulted in lower average recovery of 83.8%.

Gold production for the quarter was lower than the second quarter, as expected in the mine plan as the Phase 2 open pit nears completion and processing occurs from the lower grade stockpiles. Year to date attributable gold production was 52,652 ounces. Co-product cash costs (refer to "Non-IFRS Measures") per ounce of gold sold year to date were US\$295 and all in sustaining costs were US\$336 per ounce of gold sold.

The average realizable gold price (refer to "Non-IFRS Measures") at South Arturo for the quarter was \$1,587 per ounce and \$1,635 per ounce year to date.

COMMITMENTS AND CONTINGENCIES

Environmental Rehabilitation Provision

The Corporation currently has six environmental rehabilitation obligations related to past and current mining activities as per the table below. The provisions for each project are updated quarterly for a change to the risk free discount rate, accretion and currency adjustments if applicable. Changes in estimate on the projects are applied where an engineering assessment on the project has been carried out.

Northern Empire Mill, Ontario

Closure related activities were confined to the Blackwater River sediment study during third quarter, resulting in expenditures of \$14,174. The adit securing program has been re-scheduled to 2018.

Faymar Deloro, Ontario

There was a total of \$53,615 of expenditures in the third quarter for completing the field work portion and analysis for the crown pillar study as well as the finishing touches on the shaft and raise cap construction areas and completing the summer round of the surface water quality monitoring program.

Hasaga, Ontario

The property is currently being assessed for potential development. As such, there has been no expenditures year to date or expected in the near future related to progressive rehabilitation or closure.

McCoy-Cove, Nevada

There was \$53,371 in expenditures during the third quarter and \$119,872 year to date. The McCoy-Cove reclamation obligation includes the McCoy portion of the property purchased from Newmont Mining Corporation in 2014. The property had a remaining obligation from previous mining activities, most of which was completed prior to acquiring the property. There are ongoing reclamation activities related to the tailings dam and the cleanup of the old pads. Structural reclamation is on hold for several years pending a new mine plan for the property. There was no third quarter activity on the underground development provision recognized in the second quarter.

South Arturo, Nevada

The South Arturo reclamation obligation is managed by Barrick and is based on a 20 year reclamation plan with minimal expenditures until 2021. Main reclamation activities will begin in 2025. There were no reclamation expenditures related to closure activities during the quarter and year to date.

Mercedes, Mexico

There were no reclamation expenditures related to closure activities during the third quarter and year to date. The Corporation recognized a new liability of \$4,511,275 due to the incorporation in the Plan of Rehabilitation for a second tailings facility, the inclusion of the disturbances of the Diluvio mine and the rehabilitation of other areas as well as a change in estimate of \$4,649,298 on the existing provision based on engineering assessments and timing adjustments.

Gold Forward Contracts

At September 30, 2017, the Corporation held forward contracts requiring the delivery of 2,250 ounces of gold per month at a price of \$1,625 per ounce and 1,600 ounces of gold per month at a price of \$1,650 per ounce from until December 2017. The Corporation also entered into forward contracts requiring delivery of 1,500 ounces of gold per month at a price of US\$1,280 per ounce from January 2018 to December 2018.

The contracts required no cash or other consideration. If the contracted ounces are not delivered on the delivery date, as per the terms of the agreement, the Corporation will compensate the counterparty for the difference between the contract price and the market price per ounce on the delivery date.

Surety Bonds

At September 30, 2017 the Corporation has outstanding surety bonds in the amount of US\$7,023,968 in favour of the United States Department of the Interior, Bureau of Land Management ("BLM") as financial support for environmental reclamation and exploration permitting. The surety bonds are secured by a US\$600,000 deposit and are subject to fees competitively determined in the market place. The obligations associated with these instruments are generally related to performance requirements that the Corporation addresses through its ongoing operations. As specific requirements are met, the BLM as beneficiary of the instrument will return the instrument to the issuing entity. As these instruments are associated with operating sites with long lived assets, they will remain outstanding until closure.

Off Balance Sheet Arrangements

The Corporation has not participated in off-balance sheet or income statement arrangements other than the surety bonds discussed above.

SUBSEQUENT EVENTS

Debt repayment

On November 6, 2017 the Corporation paid \$25,000,000USD plus accrued interest of \$150,000USD to Orion on exercise of the option to repay a portion of the term facility due June 30, 2018 as discussed in Note 11.

Related party transaction

On November 3, 2017 the Corporation entered into an agreement to purchase the commercial real estate complex where the Corporation's Canadian head office is located effective November 30, 2017. The property is to be purchased at its fair market value ("FMV") from Alyris Leasing Inc., a company related to the Corporation through Ewan Downie, Director, President and Chief Executive Officer of the Corporation and Steve Filipovic, Chief Financial Officer of the Corporation. The FMV of the property, as determined through independent appraisal, was \$2,100,000. The two independent appraisals used to determine the FMV were prepared by certified appraisers engaged by an independent member of the Corporation's Board of Directors (the "Board") under the supervision and direction of the Corporation's Board and Corporate Counsel. The decision to purchase commercial real estate is consistent with the Board's directive to eliminate ongoing related party transactions and is supported by the economic advantages associated with owning as opposed to leasing this commercial real estate.

CRITICAL ACCOUNTING JUDGEMENTS AND ESTIMATES, POLICIES AND CHANGES

Significant accounting judgements and estimates

The preparation of financial statements in accordance with IFRS requires management to make judgements, estimates and assumptions about the carrying amounts of assets and liabilities, disclosure of commitments and contingent liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. The determination of estimates requires the exercise of judgement based on various assumptions and other factors such as historical experience, current and expected economic conditions. Actual results could differ from these estimates.

The significant judgements and estimates used in the preparation of the audited consolidated financial statements that have a significant risk of causing a material adjustment to the carrying amount of assets and liabilities and earnings within the next financial year include:

Business combinations

Determination of whether a group of assets acquired and liabilities assumed constitute the acquisition of a business or an asset may require the Corporation to make certain judgements as to whether or not the assets acquired and liabilities assumed include the inputs, processes and outputs necessary to constitute a business as defined in IFRS 3 Business Combinations.

Purchase price allocation

Applying the acquisition method to business combinations requires each identifiable asset and liability to be measured at its acquisition date fair value. The excess, if any, of the fair value of consideration over the fair value of the net identifiable assets acquired is recognized as goodwill. The determination of the acquisition date fair values require management to make assumptions and estimates about future events. The assumptions and estimates relating to determining the fair value of property, plant and equipment acquired generally require a high degree of judgement, and include estimates of mineral reserves acquired, future metal prices and discount rates. Changes in any of the assumptions or estimates used in determining the fair value of acquired assets and liabilities could affect the amounts assigned to assets, liabilities and goodwill in the purchase price allocation.

Inventory valuation

Finished goods, work-in-process, heap leach ore and stockpile ore are valued at the lower of costs and net realizable value. The assumptions used in the valuation of work-in process inventories include estimates of gold contained in the ore stacked on leach pads, assumptions of the amount of gold stacked that is expected to be recovered from the leach pads, the amount of gold in the mill circuits and assumption of the gold price expected to be realized when the gold is recovered. If these estimates or assumptions prove to be inaccurate, the Corporation could be required to write-down the recorded value of its work-in process inventories and heap leach ore, which would reduce earnings and working capital.

Impairment and reversal of impairment for non-current assets

Non-current assets are tested for impairment at the end of each reporting period if in management's judgement there is an indicator of impairment. If there are indicators, management performs an impairment test on the major assets within this balance.

In the case of mineral property assets, recoverability is dependent on a number of factors common to the natural resource sector. These include the extent to which the Corporation can continue to renew its exploration and future development licenses with local or other authorities, establish economically recoverable reserves on its properties, the availability of the Corporation to obtain necessary financing to complete the development of such reserves and future profitable production or proceeds from the disposition thereof. The Corporation will use the evaluation work of professional geologists, geophysicists and engineers for estimates in determining whether to commence or continue mining and processing. These estimates generally rely on scientific and economic assumptions, which in some instances may not be correct, and could result in the expenditure of substantial amounts of money on a deposit before it can be determined whether or not the deposit contains economically recoverable mineralization.

Recoverable ounces

The carrying amount for each of the Corporation's mining properties is depleted based on recoverable ounces contained in proven and probable mineral reserves. Changes to estimates of recoverable ounces and depletable costs including changes resulting from revisions to mine plans and changes in metal price forecasts can result in a change in future depletion rates.

The figures for mineral reserves and mineral resources are determined in accordance with National Instrument 43-101 Standards of Disclosure for Mineral Projects, issued by the Canadian Securities Administrators. This National Instrument lays out the standards of disclosure for mineral projects including rules relating to the determination of mineral reserves and mineral resources. There are numerous uncertainties inherent in estimating mineral reserves and mineral resources, including many factors beyond the Corporation's control. Such estimation is a subjective process, and the accuracy of any mineral reserve or mineral resource estimate is a function of the quantity and quality of available data and of the assumptions made and judgements used in engineering and geological interpretation. Differences between management's assumptions, and actual events including economic assumptions such as metal prices and market conditions, could have a material effect in the future on the Corporation's financial position and results of operation.

Asset retirement obligations

Management assesses the asset retirement obligations on an annual basis or when new information becomes available. This assessment includes the estimation of the future rehabilitation costs required based on the existing laws and regulations in each jurisdiction the Corporation operates in, the timing of these expenditures, and the impact of changes in the discount rate. The actual future expenditures may differ from the amounts currently provided if the estimates made are significantly different than actual results or if there are significant changes in environmental and / or regulatory requirements in the future.

Valuation of financial instruments

The fair value of derivative financial liabilities that are not traded in an active market, including the offtake agreement entered into during the period, is determined using valuation techniques. The Corporation uses its judgment to select a variety of methods and make assumptions that are based on market conditions existing at the end of each reporting period as an indication of the expected future market conditions. The Corporation has used a discounted cash flow analysis for the offtake agreement, incorporating key assumptions for the production to be delivered under the offtake agreement, expected metal prices and discount to metal prices during the quotational period, and discount rates that are commensurate with the risks associated with the financial liability to reflect the time value of money.

The Corporation also issued warrants either in connection with a private placement or as purchase consideration in a business combination and are recorded within share capital. Where the warrants are issued in non-brokered private placements, the warrants are equity instruments and not financial liabilities. Where the warrants are issued in conjunction with a business combination, the warrants are fair valued as one of the instruments included in the consideration. As such, in determining fair value, management judgement is required in respect to input variables of the financial model used for estimation purposes. These variables include such inputs as the Corporation's stock price, stock price variability, trading volumes and risk-free rates of return.

Functional currency of foreign subsidiaries

A significant judgement that members of management have made in the process of applying the Corporation's accounting policies and that have a significant effect on the amounts recognized in the consolidated financial statements is the policy on functional currency of foreign subsidiaries.

Management uses its judgement to determine the functional currency that most faithfully represents the economic effects of the underlying transactions, events and conditions. As part of this approach, management gives priority to indicators like the currency that mainly influences costs and the currency in which those costs will be settled and the currency in which funds from financing activities are generated. Management also assesses the degree of autonomy the foreign operation has with respect to operating activities.

Deferred income taxes

The Corporation operates in several tax jurisdictions and is required to estimate the income tax provision in each of these jurisdictions in preparing its financial statements. The provision for income taxes which is included in the consolidated statements of income (loss) and comprehensive income (loss) and composition of deferred income tax liabilities included in the consolidated statements of financial position is based on factors such as tax rates in the different jurisdictions, changes in tax law and management's assessment of future results and have not yet been confirmed by the taxation authorities. The Corporation does not recognize deferred tax assets where management does not expect such assets to be realized based on current forecasts.

In the event that actual results differ from these estimates, adjustments are made in future periods and changes in the amount of amount of deferred tax assets recognized may be required. These adjustments could materially impact the financial position and income or loss for the period.

Other estimates

Other significant estimates which could materially impact the financial statements include:

- Inputs used in accounting for share purchase option expense in the consolidated statements of income / (loss).
- Estimated useful lives of property, plant and equipment which are included in the consolidated statements of financial position and related depreciation included in the consolidated statements of loss and comprehensive loss.
- Discount rate used to determine the carrying value of long term debt.

Recent accounting pronouncements

Accounting standards issued and effective January 1, 2017 or later

IAS 7 – *Statement of Cash Flows*

Amendments to IAS 7 – *Statement of Cash Flows* require disclosures that enable users of financial statements to evaluate changes in liabilities arising from financing activities, including both changes arising from cash flow and non-cash changes. The amendments apply prospectively for annual periods beginning on or after January 1, 2017, with earlier application permitted. The Corporation has adopted the amendments to IAS 7 in its financial statements for the annual period beginning on January 1, 2017 and has disclosed the required information.

IAS 12 – *Income Taxes*

On January 19, 2016, the IASB issued *Recognition of Deferred Tax Assets for Unrealized Losses* (Amendments to IAS 12). The amendments apply retrospectively for annual periods beginning on or after January 1, 2017 and earlier application is permitted. The amendments clarify that the existence of a deductible temporary difference depends solely on a comparison of the carrying amount of an asset and its tax base at the end of the reporting period, and is not affected by possible future changes in the carrying amount. The Corporation has adopted the amendments to IAS 12 in its financial statements for the annual period beginning on January 1, 2017 with no resulting adjustments.

IFRS 9 – *Financial Instruments*

IFRS 9, *Financial Instruments* ("IFRS 9"), replacing IAS 39, *Financial Instruments: Recognition and Measurement* ("IAS 39"), introduces new requirements for the recognition and measurement of financial assets and liabilities, a single, forward-looking "expected loss" impairment model and a reformed approach to hedge accounting. IFRS 9 uses a single approach to determine whether a financial asset is measured at amortized cost or fair value, replacing the multiple rules previously under IAS 39. Most of the requirements in IAS 39 for classification and measurement of financial liabilities were carried forward unchanged to IFRS 9, except that an entity choosing to measure a financial liability at fair value will present the portion of any change in its fair value due to changes in the entity's own credit risk in other comprehensive income, rather than within profit or loss. The International Accounting Standards Board ("IASB") requires an entity to apply IFRS 9 for annual periods beginning on or after January 1, 2018.

The Corporation continues to assess the impact that the changes to IFRS 9 may have on the consolidated financial statements. The Corporation's financial assets have been comprised of Canadian equities and derivatives including put options or forward contracts for the delivery of gold ounces at various prices to manage exposure to fluctuations in gold prices. Financial liabilities include credit facilities with embedded derivatives related to various components of the agreements. The preliminary assessment of impact in applying IFRS 9 is summarized below:

- The Corporation does not hold put options at this time and the forward contracts currently held are intended to be settled using our own production and therefore the contracts are being accounted for under the own use exemption and the value of the contracts is not recognized in the financial statements, this is not expected to change under IFRS 9.

- As most of the requirements in IFRS 9 have been retained for financial liabilities and the Corporation has accounted for the embedded derivatives at fair value, significant adjustments are not expected.
- With respect to term modification of a debt instrument, the Corporation is in compliance with IFRS 9 by continuing its current practice of assessing change of terms of debt instruments in order to determine if the modification of the terms is substantial and would result in an extinguishment of the original liability and recognition of the amended debt instrument as a new financial liability. The standard requires that when a financial liability at amortized cost is modified or exchanged, and such modification does not result in derecognition, that the adjustment to amortized cost of the financial liability is recognized in profit or loss. To transition from IAS 39 to IFRS 9, the Corporation will provide the required disclosure and recognize any difference between the previous carrying amount and the carrying amount at the beginning of the annual reporting period that includes the date of initial application in the opening retained earnings of that period if applicable.

Application of IFRS 9 on the Corporation's other financial instruments is not expected to have a significant impact on the Corporation's financial position or results of operations. The Corporation expects to report more detailed information, including estimated quantitative financial impacts, if material, in its 2017 annual consolidated financial statements.

IFRS 15 – Revenue from Contracts with Customers

In May 2014, IFRS 15, *Revenue from Contracts with Customers* ("IFRS 15") was issued which establishes a single comprehensive model for entities to use in accounting for revenue arising from contracts with customers. IFRS 15 will supersede the current revenue recognition guidance including IAS 18 *Revenue*, IAS 11 *Construction Contracts* and the related interpretations and is effective for annual reporting periods beginning on or after January 1, 2018 with early adoption permitted. Entities have the option of using either a full retrospective or a modified retrospective approach to adopt the guidance.

The Corporation's revenue is generated mainly from the sale of gold and silver through various revenue streams. Typical for the mining industry, each metal sale transaction is stand alone and without multiple element arrangements. For gold and silver sales, revenue is recognized after the related performance obligations have been met which is concluded to be essentially the same under IFRS 15 and IAS 18. In general, the performance obligations of the sale transactions are satisfied at a point in time with reliably measurable transaction prices and no financing consideration due to the nature of the commodity market where the Corporation operates. An exception may exist for the gold prepay and silver stream deferred revenue arrangements that the Corporation entered into in 2016 as to the financing component. The Corporation expects to report more detailed information, including estimated quantitative financial impacts, if material, in its 2017 annual consolidated financial statements.

IFRS 16, Leases

IFRS 16, Leases is effective for annual reporting periods beginning January 1, 2019 although early application is permitted for companies that also apply IFRS 15. The Corporation is assessing the impact of this standard.

NON-IFRS MEASURES

The Corporation has included certain terms or performance measures commonly used in the mining industry that are not defined under International Financial Reporting Standards ("IFRS") in this document. These include: cash cost per ounce sold, all in sustaining cost ("AISC") per ounce sold, earnings before interest, tax, depreciation and amortization ("EBITDA"), free cash flow and average realized price per ounce. Non-IFRS measures do not have any standardized meaning prescribed under IFRS, and therefore, they may not be comparable to similar measures employed by other companies. The data presented is intended to provide additional information and should not be considered in isolation or as a substitute for measures prepared in accordance with IFRS and should be read in conjunction with the Corporation's consolidated financial statements.

Definitions

All in sustaining costs on a by-product basis per ounce include total production cash costs on a by-product basis plus incorporates costs related to sustaining production.

All in sustaining costs on a co-product basis per ounce include total production cash costs on a co-product basis plus incorporates costs related to sustaining production.

Average realized gold price represents the sale price of gold per ounce before deducting mining duty (Mexico).

Average realized silver price represents the sale price of silver per ounce before deducting mining duty (Mexico).

By-product credits include revenues from the sale of by-products from our operating mines.

Capital expenditure (sustaining) is a capital expenditure necessary to maintain existing levels of production. The sustaining capital expenditures maintain the existing mine fleet, mill and other facilities so that they function at levels consistent from year to year.

Cost of sales per ounce sold is calculated by dividing the attributable cost of sales by the attributable ounces sold.

EBITDA - Earnings before interest, tax, depreciation and amortization.

Exploration and evaluation (sustaining) expenses is presented as mine site sustaining if it supports current mine operations.

Free cash flow is calculated as cash flow from operating activities less capital expenditures.

Rehabilitation – accretion and amortization includes depreciation on the assets related to the rehabilitation provision of our gold operations and accretion on the rehabilitation provision of our gold operations.

Cash costs

Cash costs per ounce sold represents all direct and indirect operating costs related to the physical activities of producing gold, including on-site mining costs, processing, third-party smelting, refining and transport costs, on-site general and administrative costs and royalties (State of Nevada net proceeds taxes are excluded). Cash costs incorporate the Corporation's share of production costs but exclude, among other items, the impact of depreciation, depletion and amortization ("DD&A"), reclamation costs, financing costs, capital development and exploration and income taxes. In order to arrive at consolidated cash costs, the Corporation includes its attributable share of total cash costs from operations where less than 100% interest in the economic share of production is held.

Cash costs are computed on a co-product basis, however, by-product cost per ounce metrics have also been provided in order to provide more information to the Corporation's stakeholders.

Cash cost: by-product - When deriving the cash costs: by product associated with an ounce of gold, the Corporation includes by-product credits, as the Corporation considers that the cost to produce the gold is reduced as a result of the by-product sales incidental to the gold production process. Accordingly, total production costs are reduced for revenues earned from silver sales.

Cash cost: co-product - When deriving the cash costs associated with an ounce of gold, the Corporation allocates a share of production costs to the co-product based on the ratio of silver sales dollars to gold sales dollars.

Cash costs per ounce is a common performance measure in the mining industry, but does not have any standardized meaning. In determining its cash cost and cash cost per ounce, the Corporation has considered the guidelines provided by the World Gold Council, a non-regulatory, non-profit market development organization for the gold industry. A corporation's adoption of the standard is voluntary and other companies may quantify these measures differently as a result of different underlying principles and policies applied.

All in sustaining costs

AISC include total production cash costs incurred at the Corporation's mining operations, which forms the basis of the Corporation's by-product and co-product cash costs. Additionally, the Corporation includes sustaining capital expenditures which are expended to maintain existing levels of production (to which costs do not contribute to a material increase in annual gold ounce production over the next 12 months), rehabilitation accretion and amortization, general and administrative and exploration and evaluation expenses. The measure seeks to reflect the full cost of production from current operations, therefore expansionary capital is excluded. Certain other cash expenditures, including tax payments (including the State of Nevada net proceeds tax), dividends and financing costs are also excluded. The Corporation reports AISC on a per ounce sold basis.

This performance measure was adopted as a result of an initiative undertaken within the gold mining industry; however, this performance measure has no standardized meaning and should not be considered in isolation or as a substitute for measures of performance prepared in accordance with IFRS. In determining AISC, the Corporation has considered the guidelines provided by the World Gold Council, a non-regulatory, non-profit market development organization for the gold industry. A corporation's adoption of the standard is voluntary and other companies may quantify these measures differently as a result of different underlying principles and policies applied.

RISKS AND RISK MANAGEMENT

Financial Instruments and Related Risks

The Corporation's activities expose it to risks, including financial and operational risks of varying degrees of significance which could affect its ability to achieve its strategic objectives for growth and shareholder returns and which are more fully described in the risks and uncertainties section.

For financial instruments, the carrying amounts of cash and cash equivalents, receivables and accounts payable and accrued liabilities are considered to be reasonable approximations of their fair values due to the short term nature of these instruments. At September 30, 2017 and December 31, 2016, the carrying amount of restricted cash and notes payable are considered to be a reasonable approximation of their fair value as there have been no significant changes in market interest rates since inception.

Debt is initially recognized at fair value, net of any directly attributable transaction costs. Subsequent to initial recognition these financial liabilities are held at amortized cost using the effective interest method.

Derivative instruments are recorded at fair value through profit or loss and are recorded on the statement of financial position at fair market value. Fair value for derivative instruments are determined using valuation techniques with assumptions based on market conditions existing at the statement of financial position date or settlement date of the derivative.

For full details on the financial instruments and related risks affecting the Corporation, please refer to the Corporation's audited annual consolidated financial statements, notes and information for the year ended December 31, 2016.

Management of Capital Risk

The Corporation manages its share capital, equity settled employee benefits reserve, warrant reserve and contributed capital as capital. The Corporation's objectives when managing capital are to safeguard the Corporation's ability to continue as a going concern in order to pursue the exploration and development of its mineral properties and to maintain a flexible capital structure which optimizes the costs of capital at an acceptable risk.

The Corporation manages the capital structure and makes adjustments to it in light of changes in economic conditions and the risk characteristics of the underlying assets. To maintain or adjust the capital structure, the Corporation may attempt to issue new shares, acquire or dispose of assets, utilize existing credit facilities or acquire new debt.

In order to maximize ongoing exploration and development efforts, the Corporation does not pay out dividends. The Corporation's investment policy is to invest its short-term excess cash in highly liquid short-term interest bearing investments with short-term maturities, selected with regard to the expected timing of expenditures from continuing operations.

To effectively manage its capital requirements, the Corporation has in place a planning and budgeting process to help determine the funds required to ensure the Corporation has the appropriate liquidity to meet its operating and growth objectives. The Corporation expects its current capital resources will be sufficient to carry out its exploration and evaluation plans through 2018.

Risks and Uncertainties

Fluctuating Commodity Prices

Historically, gold prices have fluctuated widely and are affected by numerous external factors beyond Premier's control, including industrial and retail demand, central bank lending, sales and purchases of gold, forward sales of gold by producers and speculators, production and cost levels in major producing regions, short-term changes in supply and demand because of speculative hedging activities, confidence in the global monetary system, expectations of the future rate of inflation, the strength of the US dollar (the currency in which the price of gold is generally quoted), interest rates, terrorism and war, and other global or regional political or economic events. Resource prices have fluctuated widely and are sometimes subject to rapid short-term changes because of speculative activities. The exact effect of these factors cannot be accurately predicted, but any one of, or any combination of, these factors may result in not receiving an adequate return on invested capital and a loss of all or part of an investment in securities in Premier.

Dependence on Key Personnel

Premier's success is dependent on a relatively small number of key employees. The loss of one or more of these key employees, if not replaced, could materially adversely affect Premier's business, results of operations and financial condition.

Dependence on Third Parties

Premier relies significantly on strategic relationships with other entities and also on good relationships with regulatory and governmental departments. Premier also relies upon third parties to provide essential contracting services. In some cases, Premier holds its interest in its properties through joint ventures. In certain cases, including the South Arturo Mine and the Rahill Bonanza Project, Premier is not the manager of the joint venture. In these situations the joint venture decision may not accord with Premier's stated or desired plan. There can be no assurance that Premier's existing relationships will continue to be maintained or that new ones will be successfully formed and Premier could be adversely affected by changes to such relationships or difficulties in forming new ones. Any circumstance, which causes the early termination or nonrenewal of one or more of these key business alliances or contracts, could adversely impact Premier, its business, operating results and prospects.

No Assurance of Title

The acquisition of title to mineral projects is a very detailed and time consuming process. Although Premier has taken precautions to ensure that legal title to its property interests is properly recorded in the name of Premier where possible, there can be no assurance that such title will ultimately be secured. Furthermore, there is no assurance that the interests of Premier in any of its properties may not be challenged or impugned. Title insurance is generally not available for mineral properties and Premier has a limited ability to ensure that it has obtained secure claim to individual mineral claims. While Premier intends to take all reasonable steps to maintain title to its mineral properties, there can be no assurance that Premier will be successful in extending or renewing mineral rights on or prior to expiration of their term or that the title to any such properties will not be affected by an unknown title defect.

Construction and Start-up of New Mines

The success of construction projects and the start up of new mines by the Corporation is subject to a number of factors including the availability and performance of engineering and construction contractors, mining contractors, suppliers and consultants, the receipt of required governmental approvals and permits in connection with the construction of mining facilities and the conduct of mining operations (including environmental permits), the successful completion and operation of ore passes, the adsorption/desorption/recovery plants and conveyors to move ore, among other operational elements. Any delay in the performance of any one or more of the contractors, suppliers, consultants or other persons on which the Corporation is dependent in connection with its construction activities, a delay in or failure to receive the required governmental approvals and permits in a timely manner or on reasonable terms, or a delay in or failure in connection with the completion and successful operation of the operational elements in connection with new mines could delay or prevent the construction and start up of new mines as planned. There can be no assurance that current or future construction and start up plans implemented by the Corporation will be successful, that the Corporation will be able to obtain sufficient funds to finance construction and start up activities, that personnel and equipment will be available in a timely manner or on reasonable terms to successfully complete construction projects, that the Corporation will be able to obtain all necessary governmental approvals and permits or that the completion of the construction, the start up costs and the ongoing operating costs associated with the development of new mines will not be significantly higher than anticipated by the Corporation. Any of the foregoing factors could adversely impact the operations and financial condition of the Corporation.

Permits and Licenses

The operations of Premier require licenses and permits from various governmental authorities. Premier believes that it presently holds all necessary licenses and permits required to carry on with activities which it is currently conducting under applicable laws and regulations, and Premier believes it is presently complying in all material respects with the terms of such licenses and permits. However, such licenses and permits are subject to change in regulations and in various operating circumstances. Where required, obtaining necessary licenses and permits can be a complex and time consuming process. The costs and delays associated with obtaining necessary licences and permits could stop or materially delay or restrict Premier from proceeding with the development of an exploration project. There can be no assurance that Premier will be able to obtain all necessary licenses and permits required to carry out exploration, development and mining operations at its mineral projects or that Premier will be able to comply with the conditions of all such necessary licenses and permits in an economically viable manner.

Environmental Regulations and Potential Liabilities

The operations of Premier are subject to environmental regulations promulgated by government agencies from time to time. Environmental legislation provides for restrictions and prohibitions on spills, releases or emissions of various substances produced in association with certain mining industry operations, such as seepage from tailings disposal areas, which would result in environmental pollution. In addition, certain types of operations require the submission and approval of environmental impact assessments. Environmental hazards may exist on the properties on which Premier holds interests which are unknown to Premier at present and which have been caused by previous or existing owners or operators of the properties. Failure to comply with applicable laws, regulations and permitting requirements may result in enforcement actions there under, including orders issued by regulatory or judicial authorities causing

operations to cease or be curtailed, and may include corrective measures requiring capital expenditures, installation of additional equipment, or remedial actions. Parties engaged in exploration or mining operations may be required to compensate those suffering loss or damage by reason of the exploration or mining activities and may have civil or criminal fines or penalties imposed for violations of applicable laws or regulations and, in particular, environmental laws.

Environmental legislation is evolving in a manner that will require stricter standards and enforcement, increased fines and penalties for noncompliance, more stringent environmental assessments of proposed projects and a heightened degree of responsibility for companies and their officers, directors and employees. Amendments to current laws, regulations and permits governing operations and activities of mining companies, or more stringent implementation thereof, could have a material adverse impact on Premier and cause increases in exploration expenses, capital expenditures or production costs, reduction in levels of production at producing properties, or abandonment or delays in development of new mining properties. The potential financial exposure may be significant.

Infrastructure

Mining, processing, development and exploration activities depend, to one degree or another, on adequate infrastructure. Reliable roads, railways, power sources and water supply are important determinants affecting capital and operating costs. Unusual or infrequent weather phenomena, sabotage, government or other interference in the maintenance or provision of such infrastructure could adversely affect the Corporation's operations, financial condition and results of operations.

Aboriginal Claims and Consultation Issues

Aboriginal interests and rights as well as related consultation issues may impact Premier's ability to pursue exploration, development and mining at its projects. Premier may enter into agreements with First Nations and other Aboriginal communities in order to manage its relationship with those groups but there is no assurance that claims or other assertions of rights by Aboriginal communities or consultation issues will not arise on or with respect to Premier's properties or activities. These could result in significant costs and delays or materially restrict Premier's activities.

Fluctuations in Foreign Currency Exchange Rates

A significant portion of Premier's current and proposed expenditures are made in United States dollars and Mexican Pesos. Since Premier's financial results are reported in Canadian dollars, its financial position and results will be impacted by exchange fluctuations between the Canadian dollar, the U.S. dollar and the Mexican Peso.

The effects of the foreign exchange rates on operating costs and on future cash flows may be significant. Premier does not currently have any hedging contracts in connection with its use of U.S. dollars or Mexican Pesos. Depreciation of the Canadian dollar against the U.S. dollar or Mexican Peso would increase the costs associated with the exploration and development of Premier's properties and potentially increase future operating costs, taxes and royalties paid. These increased costs could materially adversely affect Premier's results of operation and financial condition.

Availability and Costs of Infrastructure, Energy and Other Commodities

Mining, processing, capital development projects and exploration activities depend on adequate infrastructure. Reliable access to energy and power sources and water supply are important factors that affect capital and operating costs. If the Corporation does not have timely access to adequate infrastructure, there is no assurance that it will be able to start or continue exploiting and develop projects, complete them on timely basis or at all. There is no assurance that the ultimate operations will achieve the anticipated production volume, or that construction costs and operating costs will not be higher than estimates calculated.

The profitability of the Corporation's business is also affected by the market prices and availability of commodities and resources which are consumed or otherwise used in connection with the Corporation's operations and development projects such as diesel fuel, electricity, finished steel, tires, steel, chemicals and reagents. Prices of such commodities and resources are also subject to volatile price movements, which can be material and can occur over short periods of time due to factors beyond the Corporation's control.

If there is a significant and sustained increase in the cost of certain commodities, the Corporation may decide that it is not economically feasible to continue all of the Corporation's commercial production and development activities and this could have an adverse effect on profitability. Higher worldwide demand for critical resources like input commodities, drilling equipment, mobile mining equipment, tires and skilled labour could affect the Corporation's ability to acquire them and lead to delays in delivery and unanticipated cost increases, which could have an effect on the Corporation's operating costs, capital expenditures and production schedules.

Further, the Corporation relies on certain key third party suppliers and contractors for services, equipment, raw materials used in, and the provision of services necessary for, the development, construction and continuing operation of its assets. As a result, the Corporation's activities are subject to a number of risks some of which are outside its control, including negotiating agreements with suppliers and contractors on acceptable terms, the inability to replace a supplier or a contractor and its equipment, raw materials or services in the event that either party terminates the

agreement, interruption of operations or increased costs in the event that a supplier or contractor ceases its business due to insolvency or other unforeseen event and failure of a supplier or contractor to perform under its agreement with the Corporation. The occurrences of one or more of these events could have a material effect on the business, results of operations and financial condition of the Corporation.

Uncertainty of Production Estimates

Future estimates of gold production for the Corporation's operation as a whole are derived from a mining plan and these estimates are subject to change. There is no assurance the production estimates will be achieved and failure to achieve production estimates could have a materially adverse effect on the Corporation's future cash flow, results of operations and financial condition. These plans are based on, among other things, mining experience, reserve estimates, assumptions regarding ground conditions and physical characteristics of ores and estimated rates and costs of production. Actual ore production may vary from estimates for a variety of reasons, including risks and hazards of the types discussed above.

Such occurrences could result in damage to mineral properties, interruptions in production, money losses and legal liabilities and could cause a mineral property that has been mined profitably in the past to become unprofitable.

Any decrease in production or change to the timing of production or the prices realized for gold sales, will directly affect the amount and timing of the cash flow from operations. A production shortfall or any of these other factors would change the timing of the Corporation's projected cash flow and its ability to use the cash to fund capital expenditures.

Financing Risk

The ability of the Corporation to arrange additional financing in the future will depend, in part, on the prevailing debt and equity market conditions, the price of gold, the performance of the Corporation and other factors outlined herein. There can be no assurance that additional capital or other types of financing will be available if needed or that, if available, the terms of such financing will be favourable to the Corporation.

If the Corporation raises additional funds through the sale of equity securities or securities convertible into equity securities, shareholders may have their equity interest in the Corporation diluted.

In addition, failure to comply with covenants under the Corporation's current or future debt agreements or to make scheduled payments of the principal of, or to pay interest on, its indebtedness or to make scheduled payments under hedging arrangements would likely result in an event of default under the debt agreements and would allow the lenders to accelerate the debt under these agreements, which may affect the Corporation's financial condition.

Losses from or Liabilities for Risks which are not Insured

Hazards such as unusual or unexpected geological formations and other conditions are involved in mineral exploration and development and mining. The Corporation may become subject to liability for pollution, cave-ins or hazards against which it cannot insure or against which it may elect not to insure. The payment of such liabilities would have a material, adverse effect on the Corporation's financial position and results of operations.

Although the Corporation maintains liability insurance in an amount which it considers adequate, the nature of these risks is such that liabilities might exceed policy limits, the liabilities and hazards might not be insurable against, or the Corporation might not elect to insure itself against such liabilities due to high premium costs or other reasons, in which event the Corporation could incur significant costs that could have a materially adverse effect upon its financial condition and results of operations.

Governmental Regulation

Exploration, development and mining of minerals are subject to extensive federal, provincial, state and local laws and regulations governing acquisition of the mining interests, prospecting, development, mining, production, exports, taxes, labour standards, occupational health, waste disposal, toxic substances, water use, land use, land claims that may be brought by First Nations and other aboriginal groups, environmental protection and remediation, endangered and protected species, mine safety and other matters. No assurance can be given that new rules and regulations will not be enacted or that existing rules and regulations will not be applied or amended in a manner that could have a material adverse effect on the business, financial condition and results of operations of Premier. The costs and delays associated with obtaining necessary licences and permits and complying with these licences and permits and applicable laws and regulations could stop or materially delay or restrict Premier from proceeding with the development of a project. Any failure to comply with applicable laws and regulations or licences and permits, even if inadvertent, could result in interruption or closure of exploration, development or mining operations or material fines, penalties or other liabilities. Premier may be required to compensate those suffering loss or damage by reason of its mining operations and may have civil or criminal fines or penalties imposed for violations of such laws, regulations and permits.

These laws and regulations are administered by various governmental authorities including the federal, provincial and municipal governments of Canada, the USA and Mexico.

Health and Safety

Mining operations generally involve a high degree of risk. Personnel involved in the Corporation's operations are subject to many inherent risks, including but not limited to, rock bursts, cave-ins, flooding, fall of ground, electricity, slips and falls and moving equipment that could result in occupational illness, health issues and personal injuries. The Corporation has implemented various health and safety measures designed to mitigate such risks. Such precautions, however, may not be sufficient to eliminate health and safety risks and employees, contractors and others may not adhere to the occupational health and safety programs that are in place. Any such occupational health and personal safety issues may adversely affect the business of the Corporation and its future operations.

Tax Matters

The Corporation's taxes are affected by a number of factors, some of which are outside of its control, including the application and interpretation of the relevant tax laws and treaties. If the Corporation's filing position, application of tax incentives or similar 'holidays' or benefits were to be challenged for whatever reason, this could have a material adverse effect on the Corporation's business, results of operations and financial condition.

The Corporation is subject to routine tax audits by various tax authorities. Tax audits may result in additional tax, interest payments and penalties which would negatively affect the Corporation's financial condition and operating results. New laws and regulations or changes in tax rules and regulations or the interpretation of tax laws by the courts or the tax authorities may also have a substantial negative impact on the Corporation's business. There is no assurance that the Corporation's current financial condition will not be materially adversely affected in the future due to such changes.

Information technology

The Corporation is reliant on the continuous and uninterrupted operations of its Information Technology ("IT") systems. User access and security of all IT systems are critical elements to the operations of the Corporation. Protection against cyber security incidents and cloud security, and security of all of the Corporation's IT systems are critical to the operations of the Corporation. Any IT failure pertaining to availability, access or system security could result in disruption for personnel and could adversely affect the reputation, operations or financial performance of the Corporation.

The Corporation's IT systems could be compromised by unauthorized parties attempting to extract business sensitive, confidential or personal information, corrupting information or disrupting business processes or by inadvertent or intentional actions by the Corporation's employees or vendors. A cyber security incident resulting in a security breach or failure to identify a security threat, could disrupt business and could result in the loss of business sensitive, confidential or personal information or other assets, as well as litigation, regulatory enforcement, violation of privacy and security laws and regulations and remediation costs.

Labour Difficulties

Factors such as work slowdowns or stoppages caused by the attempted unionization of operations and difficulties in recruiting qualified miners and hiring and training new miners could materially adversely affect the Corporation's business. This would have a negative effect on the Corporation's business and results of operations which might result in the Corporation not meeting its business objectives.

Nature of Mineral Exploration and Mining

The economics of exploring and developing mineral properties are affected by many factors including capital and operating costs, variations of the grades and tonnages of ore mined, fluctuating mineral market prices, costs of mining and processing equipment and such other factors as government regulations, allowable production, importing and exporting of minerals and environmental protection.

The effect of these factors cannot be accurately predicted, but the combination of these factors may result in Premier not receiving an adequate return on invested capital. The operations of Premier are also subject to all of the hazards and risks normally incidental to exploration and development of mineral properties, any of which could result in damage to life or property, environmental damage and possible legal liability for any or all damage. The activities of Premier may be subject to prolonged disruptions due to inclement or hazardous weather conditions depending on the location of operations in which Premier has interests. Hazards, such as unusual or unexpected geological formations, rock bursts, formation pressures, cave-ins, flooding or other conditions may be encountered in the drilling and removal of material. Other risks include, but are not limited to, mechanical equipment performance problems, industrial accidents, labour disputes, drill rig shortages, the unavailability of materials and equipment, power failures, hydrological conditions, earthquakes, fires, landslides and other Acts of God. While Premier may obtain insurance against certain risks in such amounts as it considers adequate, the nature of these risks are such that liabilities could exceed policy limits or could be excluded from coverage. There are also risks against which Premier cannot insure or against which it may elect not to insure. The potential costs which could be associated with any liabilities not covered by insurance

or in excess of insurance coverage or compliance with applicable laws and regulations may cause substantial delays and require significant capital outlays, adversely affecting the future earnings and competitive position of Premier and, potentially, its financial position.

Estimates of Mineral Resources and Mineral Reserves

Mineral reserves and mineral resources are estimates only, and no assurance can be given that the anticipated tonnages and grades will be achieved, that the indicated level of recovery will be realized or that mineral reserves can be mined or processed profitably. Mineral reserve and mineral resource estimates may be materially affected by environmental, permitting, legal, title, taxation, sociopolitical, marketing and other relevant issues. There are numerous uncertainties inherent in estimating mineral reserves and mineral resources, including many factors beyond the Corporation's control. Such estimation is a subjective process, and the accuracy of any mineral reserve or mineral resource estimate is a function of the quantity and quality of available data, the nature of the ore body and of the assumptions made and judgments used in engineering and geological interpretation. These estimates may require adjustments or downward revisions based upon further exploration or development work or actual production experience. Fluctuations in gold or silver prices, results of drilling, metallurgical testing and production, the evaluation of mine plans after the date of any estimate, permitting requirements or unforeseen technical or operational difficulties, may require revision of mineral reserve and mineral resource estimates. Prolonged declines in the market price of gold (or applicable by-product metal prices) may render mineral reserves containing relatively lower grades of mineralization uneconomical to recover and could materially reduce the Corporation's mineral reserves. Should reductions in mineral resources or mineral reserves occur, the Corporation may be required to take a material write-down of its investment in mining properties, reduce the carrying value of one or more of its assets or delay or discontinue production or the development of new projects, resulting in increased net losses and reduced cash flow. Mineral resources and mineral reserves should not be interpreted as assurances of mine life or of the profitability of current or future operations. There is a degree of uncertainty attributable to the calculation and estimation of mineral resources and mineral reserves and corresponding grades being mined and, as a result, the volume and grade of mineral reserves mined and processed and recovery rates may not be the same as currently anticipated. Any material reductions in estimates of mineral reserves and mineral resources, or of the Corporation's ability to extract these mineral reserves, could have a material adverse effect on the Corporation's results of operations and financial condition. Mineral resources are not mineral reserves and have a greater degree of uncertainty as to their existence and feasibility. There is no assurance that mineral resources will be upgraded to proven or probable mineral reserves.

Competition

There is significant competition in the precious metals mining industry for mineral rich properties that can be developed and produced economically, the technical expertise to find, develop, and operate such properties, the labour to operate the properties and the capital for the purpose of funding such properties. Many competitors not only explore for and mine precious metals, but conduct refining and marketing operations on a global basis. As a result of this competition, some of which is with large established mining companies with substantial capabilities and greater financial and technical resources than Premier, Premier may be unable to acquire desired properties, to recruit or retain qualified employees or to acquire the capital necessary to fund its operations and develop its projects. Existing or future competition in the mining industry could materially adversely affect Premier's prospects for mineral exploration and success in the future. Increased competition can result in increased costs and lower prices for metal and minerals produced and reduced profitability. Consequently, the revenues of Premier, its operations and financial condition could be materially adversely affected.

From time to time several companies may participate in the acquisition, exploration and development of natural resource properties thereby allowing for their participation in larger programs, permitting involvement in a greater number of programs and reducing financial exposure in respect of any one program. It may also occur that a particular company will assign all or a portion of its interest in a particular program to another of these companies due to the financial position of the company making the assignment. In determining whether or not Premier will participate in a particular program and the interest therein to be acquired by it, the directors will primarily consider the degree of risk to which Premier may be exposed and its financial position at that time.

Conflicts of Interest

The directors and officers of Premier may serve as directors or officers of other public resource companies or have significant shareholdings in other public resource companies. Situations may arise in connection with potential acquisitions and investments where the other interests of these directors and officers may conflict with the interests of Premier. In the event that such a conflict of interest arises at a meeting of the directors of Premier, a director is required by the Ontario Business Corporations Act ("OBCA") to disclose the conflict of interest and to abstain from voting on the matter.

Current Global Financial Condition

Current global financial conditions have been subject to increased volatility, and access to public financing, particularly for resource companies, has been negatively impacted. These factors may impact the ability of the Corporation to obtain equity or debt financing in the future and, if obtained, such financing may not be on terms favourable to the Corporation. If increased levels of volatility and market turmoil continue, the Corporation's operations could be

adversely impacted, and the value and price of the Common Shares could be adversely affected.

Risks Relating to Premier Common Shares Generally

No Guarantee of Positive Return on Investment

There is no guarantee that an investment in the securities of Premier will earn any positive return in the short term or long term. The mineral exploration and development business is subject to numerous inherent risks and uncertainties, and any investment in the securities of Premier should be considered a speculative investment. Past successful performance provides no assurance of any future success. The purchase of securities of Premier involves a high degree of risk and should be undertaken only by investors whose financial resources are sufficient to enable them to assume such risks. An investment in the securities of Premier is appropriate only for investors who have the capacity to absorb a loss of some or all of their investment.

Volatility of the Trading Price of Premier Common Shares

The Premier Common Shares are listed on the TSX. In recent years, the securities markets have experienced a high level of price and volume volatility, and the market price of securities of many companies, particularly those considered exploration or development stage companies, have experienced wide fluctuations in price which have not necessarily been related to the operating performance, underlying asset values or prospects of such companies. There can be no assurance that continued fluctuations in price will not occur, which may result in losses to investors. The purchase of Premier Common Shares should be undertaken only by investors who have no need for immediate liquidity in their investment. The trading price of the Premier Common Shares may increase or decrease in response to a number of events and factors, including, but not limited to: Premier's operating performance and the performance of competitors and other similar companies; volatility in gold and other metal prices; the public's reaction to Premier's press releases, other public announcements and Premier's filings with the various securities regulatory authorities; the failure of Premier to meet the reporting and other obligations under Canadian securities laws or imposed by the TSX; changes in recommendations by research analysts who track the Premier Common Shares or the shares of other companies in the resource sector; a reduction in coverage by such research analysts; changes in general economic and/or political conditions; the arrival or departure of key personnel; and acquisitions, strategic alliances or joint ventures involving Premier or its competitors, which, if involving the issuance of Premier Common Shares, or securities exercisable or exchangeable for or convertible into Premier Common Shares, would result in dilution to present and prospective holders of Premier Common Shares. In addition, the market price of the Premier Common Shares is affected by many variables not directly related to Premier's success and are, therefore, not within Premier's control, including other developments that affect the market for all resource sector securities, the breadth of the public market for the Premier Common Shares, and the attractiveness of alternative investments. Securities class action litigation often has been brought against companies following periods of volatility in the market price of their securities. Premier may in the future be the target of similar litigation. Securities litigation could result in substantial costs and damages and divert management's attention and resources.

No Dividend Record

Premier does not have a dividend policy and has never declared or paid any dividends to its shareholders. Premier intends to invest all available funds toward the development and growth of its business and does not expect to pay any cash dividends for the foreseeable future. The payment of any cash dividend to shareholders of Premier in the future will be at the discretion of the directors of Premier and will depend on, among other things, the financial condition, capital requirements and earnings of Premier, and any other factors that the directors of Premier may consider relevant.

Issuance of Preference Shares

As of September 30, 2017, there were no Preference Shares outstanding; however, pursuant to its articles, Premier is authorized to issue an unlimited number of Preference Shares, in one or more series, with the designation of, and the rights, privileges, restrictions and conditions attached thereto, determined at the discretion of the directors of Premier, subject to the articles of Premier and the OBCA. Payment of dividends and repayment of the liquidation preference of such Preference Shares may take preference over dividends or other payments to holders of Premier Common Shares.
